

Proposed EU legislation is set to ban – in August this year - many of the food supplements that

you rely on for your natural health

Crazy? Yes. But it will happen unless the legislation is contested. The **Alliance for Natural Health (ANH)** has already led the challenge, bringing a landmark legal case to the European Court on 25 January 2005. The Advocate General described the mechanism for selecting which vitamins and minerals will be allowed and those that won't as being 'as transparent as a black box'. The final decision will be heard in June.

There is still so much to fight for. The judges are deliberating. Legislation is likely to spread worldwide, to address dosage levels, other nutrients, herbal remedies and many other areas of natural healthcare.

We have a strong case and there is the time to influence this legislation. But only if you do something about it now. **You must not shrug your shoulders and assume there is nothing you can do.** You can. There is still time.

The ANH has achieved remarkable things, campaigning on your behalf for the things that you value, with limited support. It has got this far because its core team and many volunteers believe passionately and rationally in the benefits of natural healthcare – **based on the principles of good science and good law.** It can achieve much more, but only if it has funds. Donate to the only organisation that has the scientific and legal expertise to influence this legislation positively. **ANH needs £250,000 urgently.**
